Terms & Conditions



Dog Boarding Agreement

Client authorization & terms

- 1. I authorize Pawtriotic Pet Hotel LLC to care for my dog whilst I am away. I will fill out all necessary forms and inform Pawtriotic Pet Hotel LLC of any information I deem important regarding my dog.
- 2. I authorize Pawtriotic Pet Hotel LLC to obtain any emergency veterinary care that may be necessary during the time spent with my dog. Every effort will be made to contact the owner prior to obtaining emergency care. I accept responsibility for any charges related to this emergency care. I also authorize Pawtriotic Pet Hotel LLC to use an alternative veterinarian in the event my regular veterinarian is unavailable.
- 3. I agree to compensate Pawtriotic Pet Hotel LLC for any additional fees for providing emergency care, as well as any expenses incurred for unexpected housing, food, or supplies.
- 4. I understand I will be responsible for any medical expenses or damages resulting from an injury to the dog coach or any other persons involved by the pet. I agree to cover and hold harmless Pawtriotic Pet Hotel LLC in the event of a claim by any person injured by the dog. I accept full liability for any loss or damage caused by my dog whilst in PawSchool or Overnight Hotel Stay.
- 5. I agree to notify Pawtriotic Pet Hotel LLC of any concerns/complaints within 24 hours of any appointments.
- 6. I understand any misleading or false information may result in termination of Dog boarding agreement.

- 7. All dogs must undertake a trial stay at Pawtriotic Pet Hotel LLC prior to staying with us on a longer basis. We encourage trial stays, so your dog is familiar and comfortable with their dog coach.
- 8. I understand I must state if my dog shows aggression in any way. I understand I must fully disclose any quality or characteristic problems which might make caring, for my dog unsafe. Pawtriotic Pet Hotel LLC will not care for dogs that imperil their safety or others.

Pawtriotic Pet Hotel LLC Responsibilities

- 9. Pawtriotic Pet Hotel LLC agrees to provide the services stated in this agreement in a reliable, kind, and trustworthy manner. In consideration of these services and as an express condition thereof, the client specifically waives and relinquishes any and all claims against Pawtriotic Pet Hotel LLC, its employees, or assignments, except those occurring from the negligence of the boarder.
- 10. Pawtriotic Pet Hotel LLC will abide by the Pet Industry standards and regulations at all times
- 11. Pawtriotic Pet Hotel LLC will keep clients up to date on their dogs well being during their stay with us.
- 12. Pawtriotic Pet Hotel LLC will not let any dog out of the indoor facility unless there is an emergency evacuation issued.
- 13. Pawtriotic Pet Hotel LLC will notify the owner if any incidents occur that may impact their dogs health.

- 14. The client must make sure the dog tag is up to date and provide one for the address and phone number of the dog border address and phone number.
- 15. This agreement is valid for the assignment only. A new one must be signed for each assignment. Pawtriotic Pet Hotel LLC reserve the right to terminate this agreement at any time, at its sole discretion. The client may terminate this agreement at any time with one month's notice before the booked date.
- 16. All of the client's dogs' belongings will be returned to them at the end of their stay with us.
- 17. The client will inform their vet of their absence and give details for Pawtriotic Pet Hotel LLC.
- 18. Pawtriotic Pet Hotel LLC agree to love and care for your dog whilst you are away or at work.
- 19. Your dog must be in a clean and groomed condition and with up-to-date vaccinations, de-flea, and anti-worming treatments.

Emergency care

- 20. In case of an emergency Pawtriotic Pet Hotel LLC will contact the owner using the phone numbers on the introduction forms. The owner will then instruct Pawtriotic Pet Hotel LLC on their next action. If for whatever reason Pawtriotic Pet Hotel LLC cannot make contact with the owner, the emergency number from the introduction forms will then be called. If no contact is made Pawtriotic Pet Hotel LLC will then be authorized to transport your dog to their requested veterinarian practice and seek medical care. All costs will be covered by the owner.
- 21. Any extra supplies that are needed will be the responsibility of the client and Pawtriotic Pet Hotel LLC should be reimbursed along with fee for time.
